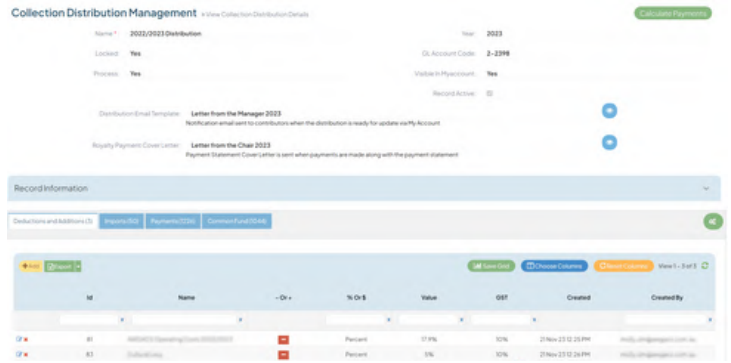

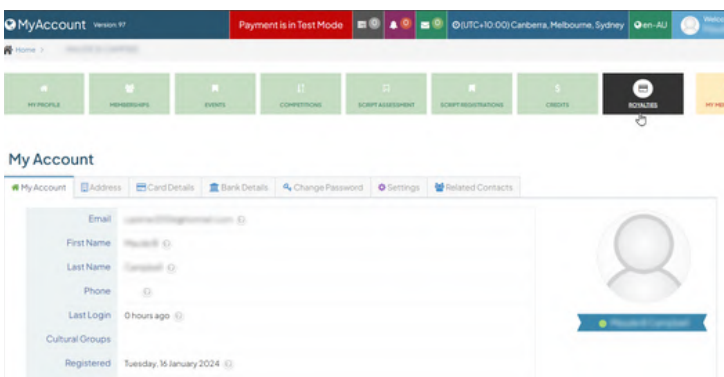


★ **Calculate Payments based on Funds Received, Processing Rules and Splits**

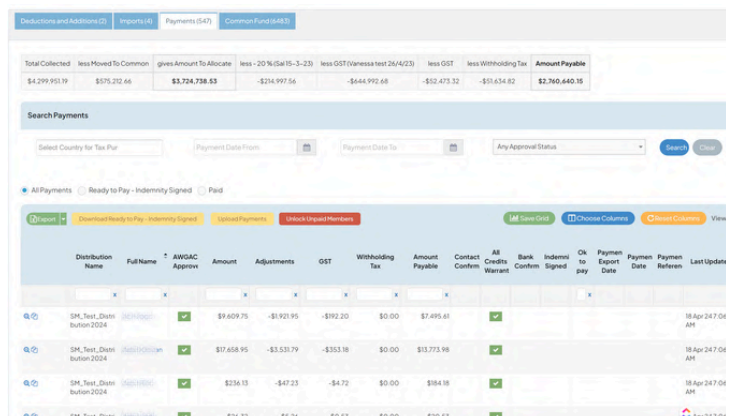
